

2019 EMG College Scholarship Nomination Guidelines

Purpose

The NCEMGVA is providing two scholarships to cover Registration Fees for two exceptional members to attend the June, 2019 EMG College at NCSU.

Scholarship Rules

- Nominations must be submitted by Extension Personnel who are Associate Members of NCEMGVA.
- Nominations must be submitted **by March 15, 2019.**
- The Nominee:
 - Must be a certified EMGV with at least 2 years experience.
 - Must be a current member of the NCEMGVA.
 - Must be or have demonstrated the potential to be an exceptional asset to the county program.
- Nominations will be evaluated by the Awards Committee and selected applications recommended to the NCEMGVA Executive Committee for approval.
- Two members will be chosen to receive the Scholarship which covers the Registration Fee for the EMG College.
- The Scholarship recipients will be recognized at the EMG College and announced in the NCEMGVA Newsletter and on the website.
- **The Extension Personnel completing the chosen applications will be notified by March 31st.**
- Registration Fee checks along with Scholarship recipient names and county names will be sent to the EMG College. **Scholarship recipients must still send in their registration (minus registration fee) by the deadline of April 15.**

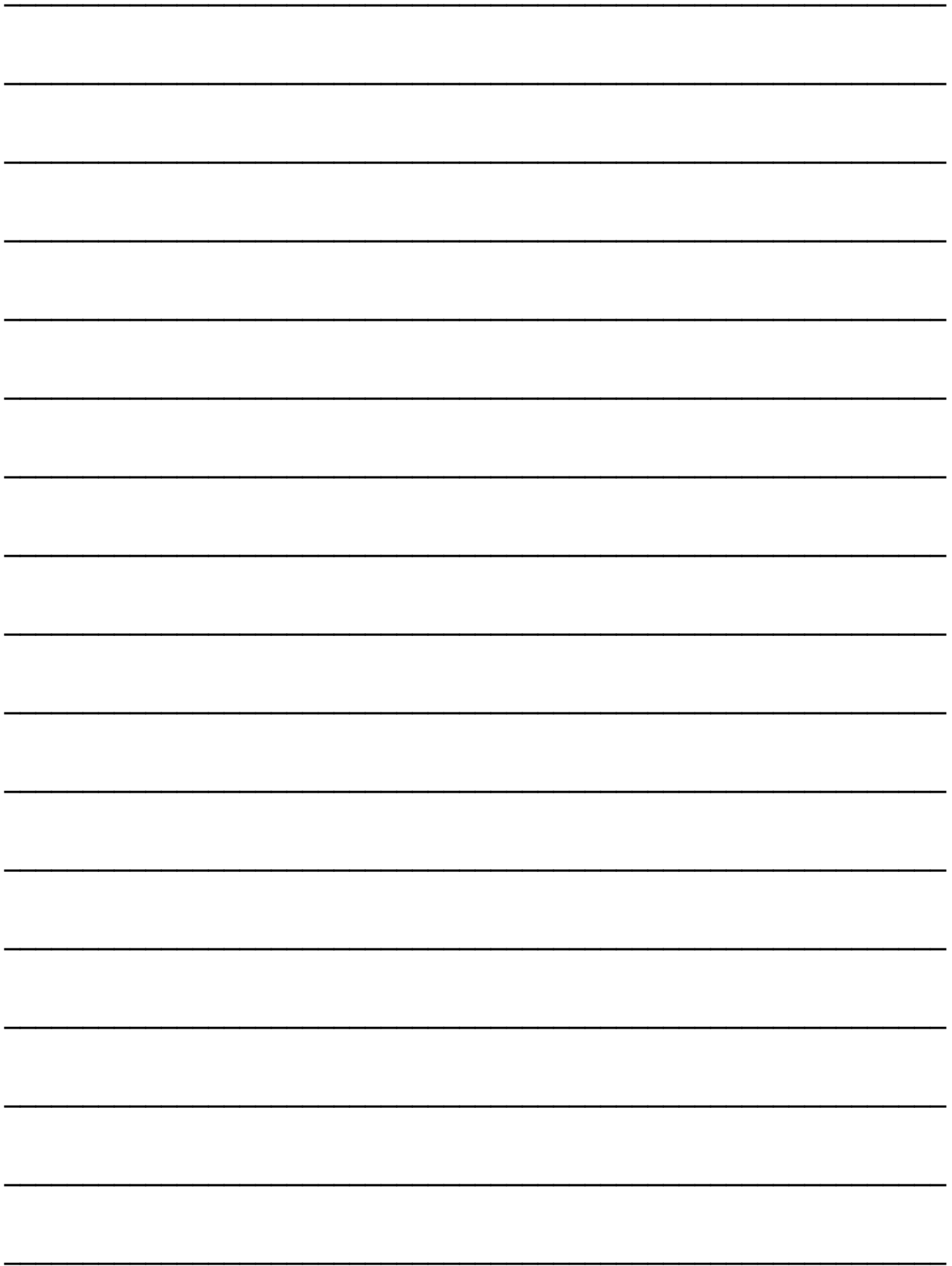
